The Clerk called the Council to order and requested that they elect one from among among their number to be Warden for the year 1928.

The Clerk requested Councillors McKnight and Asselin to act as scrutineers and declared the nominations open for the position of Warden for the year 1928.

All the nominees, with the consent of their movers and seconders, having withdrawn, except Councillors Tom, Lambert and Hambly, the Clerk proceeded to take the vote, and no candidate having received a majority of the votes of the members present the Clerk declared no election, and according to the rules the candidate that receives the least number of votes retires. The Clerk again proceeded to take the vote with Councillors Lambert and Hambly as candidates, and Councillor Lambert receiving the largest number of votes, the Clerk declared him elected Warden for the year 1928.

His Honour, Judge Wismer, held special Court, and administered the oath of office to the Warden elect.

Judge Wismer asked the representatives of the Ministerial Association of the Town of Barrie to open the proceedings of the Session.

The President of the Association, the Rev. Mr. Whan, expressed his pleasure at again being present at the opening of the January Session. He was a native of the County of Simcoe, having been born in the Town of Barrie. He had travelled in Canada and the United States and liked the County of Simcoe the best of all the places, and he had come back to minister to the people of his native Town. In his opinion environment has a lot to do in moulding the character of people.

The Council had great responsibilities and they were following men who had accomplished great things, and he was sure the present Council would measure up to any standard that had already been set.

He referred to the Children's Shelter as an Institution worthy of their best support, because it helped boys and girls to become good citizens.

The Rev. Mr. Black offered prayer.

His Honour Judge Wismer congratulated the Warden on his election to a high office. The word Warden means Guardian. All the Members were wardens because they were guardians. They were guardians over the finances of the County, which at the present time had grown to large proportions owing to the increased demands for higher education, Better types of roads, both County and Provincial and the Administration of Justice.

He expressed his satisfaction at the action of the Council in taking up the question of reforestation, a policy he had recommended to the Council many years ago when he had officiated at a ceremony similar to the present.

He was heartily in accord with the policy of reforestation of the Honourable, Mr. Finlayson, the Minister of Lands and Forests, of the Province.

He agreed with the Rev. Mr. Whan when he spoke in the interests of the Children's Shelter. A short time ago the Inspector, Mr. Justice, showed him pictures of splendid young people, who a few short years ago he had committed to the Shelter as poor neglected waifs, showing the results that were accomplished.

He referred to his pleasure at being invited to officiate at this ceremony, but still he had feeling of sadness as he thought of his friend and colleague, the late Judge Vance, who had performed it for so many years.

Moved by Councillor J. Carlton, and seconded by Councillor J.J. McKnight, and ordered.

That a vote of thanks be tendered His Honour, Judge Wismer, for his presence this afternoon, to administer the oath of office to the Warden, and for his instructive address. Also, to the Ministerial Association of Barrie, for their services this afternoon through their representatives, the Rev. Mr. Black and the Rev. Mr. Whan.

The Warden then took the chair. The Warden briefly addressed the Council and thanked the Members for his election. It would be his endeavour throughout the year to devote his best efforts in the interests of the County.

The Warden invited Ex-Wardens Davis, Coombs and Banting, and Mayor McCuaig of Barrie, to seats on the dais.

Ex-Warden Banting, the Governor of the Gaol, was glad to be here once more and he congratulated the Warden on his election, and was sure he would fill the chair with the same dis-

-tinction as his predecessors. He invited all the Members to visit him in his castle and see for themselves how he is performing his duty.

Ex-Warden Eavis expressed his pleasure at being able to be present and also congratulated the Warden on his election. He came to the County Council about nine years ago the same time as himself. The people are clamoring for improvements in Municipal administration and at the same time to keep the taxes down. Higher standards of education and road improvement called for increased expenditure and it was difficult to keep the rates from going up. He wished the Council a prosperous year.

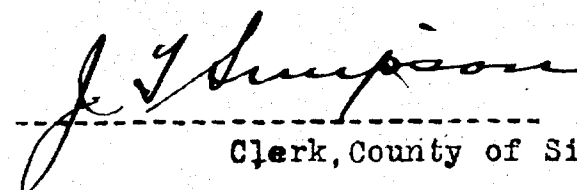

A Deputation from the Town of Alliston appeared before the Council, in the interest of an hospital in the Town.

Dr. Cunningham stated that the Town of Alliston had been anxious for some time to have an hospital, as all hospitals were doing much in the interests of health.

He was of the opinion that in the near future health centers would be established all over our Country. Alliston was situated in a centre that was far removed from any Town which had a Hospital, and was in the centre of an area with many thousands of a population. He asked for a grant towards the equipment of the hospital.

J.H. Mitchell, M.P.P. stated that in asking for a grant they would leave the amount to the generosity of the Council, and no doubt they would deal with it in the best interests of the County.
