The Clerk, having waited for fifteen Minutes, declared the nominations closed.

All the nominees, with the consent of their mover and seconder, having withdrawn, except Councillors Drinkwater and Kiernan, the Clerk proceeded to take the vote, and Councillor Drinkwater receiving a majority of the votes of the members present, the Clerk declared him duly elected Warden for the year 1936.

Magistrate Compton Jeffs, Police Magistrate, held special court and administered the declaration of office to the Warden elect. He congratulated Warden Drinkwater on the confidence expressed in him by his fellow members in electing him to be Warden of this banner County, and referred to the fact that he was made Warden the year King Edward VIII ascended the throne, and he referred to the death of our beloved Monarch King George V. He recalled his association with the County Council and commented on the fact that there were only two members in the present Council who were members with him in 1919. He wished the Council a prosperous and successful year.

The Warden then took the chair.

Mayor Robertson addressed the Council and informed the members that during their Session they had the freedom of the Town. He invited the members to a memorial Service to-morrow at eleven o'clock in remembrance of our late beloved Monarch, King George V. He referred to the death of Mr. Freeman Campbell, County Engineer, and to the death of Ex-Warden Tom of Collingwood. In both cases the County lost residents who had given valuable service to the County for a number of years.

Ex-Warden McKinley was pleased to be present and to renew old acquaintances. He made mention of the change that was continually taking place, the personnel of the Council changed very rapidly. He was glad that last year's Warden, Mr. H. J. Crawford, a resident of Oro township, filled the chair so capably and satisfactorily.

Ex-Warden Davis in addressing the Council, stated that he enjoyed being present and witnessing the election of the new Warden. He congratulated him very sincerely and wished him and the Council a successful year. It was sixteen years since he first became a member of the Council and in that time there has been a complete change in the officials in the Court House, showing how rapidly time made change.

Ex-Warden Crawford then addressed the Council. He congratulated the Warden on his election and especially as he had withdrawn from the contest for Wardenship for 1935 and permitted him to have an acclamation. He asked for the same loyal support for Warden Drinkwater that had been accorded him in 1935.

The Warden appointed Reeve Kiernan and the Reeves of all the other Municipalities with Deputy-Reeve Horne of Orillia township as a Striking Committee to name the Standing Committees for the current year.

The Council adjourned for thirty minutes to allow the Striking Committee to name the Standing Committees for the present year.

Many matters of importance would come before the Council and he requested that the members give all questions their very best attention. He asked the members to be prompt in their attendance at meetings of the Council and Committees.

He regretted the death of Mr. F. G. Campbell, County Road Superintendent, and of Ex-Warden W. A. Tom, particularly as each of these men had been a personal friend of his. He also referred to the death of Miss Kate Stevenson of the Surrogate Clerk's office, who was a capable official.

Tuesday had been proclaimed a National Holiday and Day of Mourning, and in consequence the Council or Committees would not meet that day.

MINUTES

Of the June Session, 1936, of the Municipal Council

Of the COUNTY OF SIMCOE

FIRST DAY

Council Chamber, Barrie,
June 15th, 1936.

The Council met pursuant to the adjournment at the January Session.

The Warden in the chair.

All the members of the Council were present but Councillor Smith.

The Minutes of the last meeting having been printed and distributed were
taken as read.

The Warden addressed the Council and referred to conditions in the County.
He stated that the spring season had been backward and that vegetation was injured by
early frosts, but with sufficient moisture and favourable weather recently a great improve-
ment had taken place and the present gave promise to a bountiful harvest.

He referred to the death of Ex-Warden Scott, one of the best municipal men
the County had produced. In his death his community and the whole County suffered the loss
of one of the most outstanding citizens.

During the year the County also suffered the loss of Ex-Warden Tom, W.
Mackay, Ex-reeve of Creemore, and A. C. Robins, Ex-reeve of Colwater. In the latter case,
Mr. Robins was a young man in the prime of life and during the time he was a member of the
Council he showed outstanding knowledge in Municipal affairs.

The financial condition of the County showed improvement from last year and
he quoted statistics in support of this as compared with one year ago.

The new County Road Superintendent was showing that he was obtaining thor-
ough knowledge of the County Road system. He was giving his full time to his work and was
mastering all branches pertaining to the roads.

With reference to the Moose River mining disaster in Nova Scotia which
created so much interest throughout civilization, he stated that the wife of Mr. Scadding
was a Simcoe County girl, the daughter of Henry Smith, Flos township, and a niece of Thos.
E. Smith, a former Reeve and the present Clerk of that Township.
