5. Updates on Working Groups

IEC

Group needs to be reconvened to restrategize and report needs to the council. Funding from ALLIES unavailable→ alternate sources of funding needed.

Newcomers Education

- Georgian College, YMCA, Ontario Works, Welcome Centre represented on Working Group
- What workshops are offered directly to newcomers no mandate, no influx of newcomers, moved into
 assisted services most of the time; no workshops exist at this time
- Is there a workshop that needs to be developed for service providers? Would this be beneficial?
- One on one connection with newcomers more appropriate tool for service provider health & safety, responsibilities of employers
- Produce a tip sheet for caseworkers, settlement workers
- Identify content of tip sheet deadline January 13
- Employer Education working on similar idea → connect with each other
- Needs promotion of services to newcomers resources could be a problem
- Put workshop(s) on back-burner?
- Flyers for upcoming workshops should include a banner to say newcomers welcome
- Helpful to review what is included in immigrant resource directory when available.

Professional Development

- Cultural Competency a priority
- Next meeting is set for November 7th

Employer Education

- Last meeting included discussion on the content for the employer brochure focus will continue on :
 - more detailed content
 - type of employers
 - budget/funding
 - 1 page cheat sheet in brochure tips
- Next meeting is set for November 16.

It was suggested that the working groups forward brief notes to each other after each of their meetings to avoid duplication of activities.

R. Wisken reported that the Employment chapter of the Immigrant Resource Directory is almost complete. The group worked very well together and provided information that was rich in content.

6. Year in Review

The Sub-council contemplated the year in review and noted the following:

Successes

- Tangible evidence throughout communities
- Midland immigrants not the exception anymore, more mainstream
- Shift in communications in front-line level more people to communicate within the system
- Higher level of communication
- Publications are creating awareness of hiring immigrants without group, material may be sitting on a shelf somewhere.
- Attitudinal change from first article published last year
- Increase in awareness of who is in community in Simcoe County
- Sub-council → shared helps build momentum
