County Road 88 and Sideroad 5 Intersection Improvements

The County of Simcoe has awarded the contract to Primrose Contracting for the reconstruction of the intersection of County Road 88 and Sideroad 5.

The project involves the reconstruction of approximately 1220 metres of Sideroad 5 and 590 metres of County Road 88, including addition of left turn lanes, replacement of culverts within the limits of construction, installation of guide rail plus signalization of the intersection.

Primrose Contracting anticipates commencing site works mid **April 2023**. The reconstruction work is planned to continue through to **November 2023**.

How will I get to My Residence or Business?

While the Contractor will endeavour to maintain access to all residences and businesses, there may be occasions however, where direct access to County Road 88 and/or Sideroad 5 may be interrupted.

The contractor will give prior notice of any access restrictions to any residence or business.

If you have any special needs for wheelchair access, please advise the Ainley Group Contract Administrator (Courtney Hough).

Access for emergency vehicles will be maintained at all times.

Lane Restrictions

During road reconstruction operations, traffic speed will be reduced to 50 km/h through the work zone.

Lane shifts will be used to maintain 2-lanes of traffic operation where possible and, should a temporary lane closure be required, temporary traffic signals or flagging will be used to safely maintain traffic flow.

Safety

Construction involves the use of heavy equipment and the unavoidable creation of obstacles.

We ask that you take extra caution during the construction period to ensure everyone's safety.

Additionally, we ask that you caution your children to stay clear of the working area at all times even when workers are not present.
