- Standard First Aid (SFA) <u>AND</u> BLS certification (formerly known as Health Care Provider level CPR) current within 1 year of hire
- Free of communicable diseases and have up to date vaccination status as per the Ambulance Act

Physical Testing:

The successful completion of a paramedic physical assessment, must be completed by dated **April 26**th, **2024** is required as a condition of employment. **Valid successful results dated no earlier than October 26**th, **2023.**

The County of Simcoe Paramedic Services (CSPS) will only be accepting the Ottawa Paramedic Physical Abilities Testing (OPPAT). This is a third party organization and there is a fee that is paid directly to the third party, by the applicant. The physical testing is a pass/fail component. If you have already completed the OPPAT by the date above, your results can automatically be shared with CSPS if you provide permission to the agency.

Interview Assessment / Skills Assessment:

Resume screening will be completed and those candidates who pass screening and have submitted the required non-personal documentation by January 29th will be eligible for an interview. These candidates will receive a portal link to select their interview time slot and a skills time slot on January 26th. Candidates must choose their interview slot and skills slot by January 31st. Those who are not successful in their interview process, will be contacted and released from the process and therefore will not need to attend their booked skills testing date.

Interviews will be held in person during the week of February 5th, 2024 only.

Skills testing will be held during the week of February 20th, 2024 only.

County of Simcoe Paramedic Services Orientation:

All hard copies must be presented for verification on the first day of in-person orientation.

Orientation will run from Monday to Thursday, 08:30 – 16:30 daily, from April 29th – May 16th, 2024. In addition, PCP candidates who require IV training must attend on Friday May 17th, 2024.

Orientation will consist of a combination of virtual and in-person sessions.

Attendance is mandatory for the entire orientation.
