With the consent of their mover and seconder and the Council the following members withdrew their names from the nomination for the position of Warden of the County of Simcoe for the year 1920 namely, Reeve Coombes of the Village of Bradford, Reeve Pulford of the Township of Lonsaronto, Reeve Duckworth of the Village of Victoria Harbor, Reeve Banting of the Township of Essa, Deputy Reeve Jardine of the Township of Watawasaga, Reeve Senclair of the Town of Orillia, Reeve McArthur of the Township of Oro, Reeve Loring of the Township of Matetudash, Reeve McEnright of the Village of Tottenham, Reeve Craig of the Town of Barrie. After waiting 15 minutes the Clerk declared the nominations closed.

All the other nominees for the position of Warden having withdrawn their names from the nomination, with the exception of Amos Strain Reeve of Slos the Clerk declared him duly elected Warden of the County of Simcoe for the year 1920.

His Honour Judge Vance held a Special Court and administered the oath of Office to the Warden elect. The Warden took the Chair.

The Warden then addressed the Council thanking them for the high honour they had conferred upon him in electing him to the honoured position of Warden of the County of Simcoe and he assured them he would do his utmost to fill the position to the best of his ability. He was pleased to state that he was informed by the Treasurer that the finances of the County were never in a better condition than they are at the present time.

His Honour Judge Vance addressed the Council he congratulated the Warden on his election to such an honourable position as Warden of the County of Simcoe and he was sure he would fill the position with credit to himself and the Council that elected him. The fact that he

had been elected by acclamation was compelled that he had the support and confidence of the members, He stated the position of Public men was not always an enviable one so many men were prone to criticize the actions of public men whereas if they were in the same position they in all probability would have taken the same action, It is much easier to knock down than build up and so many seem to take a pleasure in knocking although they have not the ability to build up, He was sorry he was unable to say that the unrest caused by the war was overcome in fact the world seems in a worse condition than it was at the time of the armistice, He was pleased to see the action taken by the Christian Churches in the great forward movement and hoped the members would strongly ^{support} this movement in their several Municipalities, He suggested that arrangements should be made with the Ministerial Association of the Town of Barrie to have the opening session of the Council opened by prayer by one of its Ministers

give to all the Manufacturers of this Province the same rate per Horsepower
thereby enabling them to compete on a fair basis

County Highway, commencing at the South West corner of the Township
of Nottawasaga and continuing Northward along the boundary line of
