All the nominees, with the consent of their Mover and Seconder, having withdrawn, except Councillor McKinley and Councillor Williams, the Clerk proceeded to take the vote and Councillor McKinley receiving a majority of the Members present, the Clerk declared him elected Warden for the year 1925.

His Honour, Judge Vance held special Court and administered the oath of office to the Warden Elect.

His Honour, Judge Vance asked the Members of the Ministereal Association to open the proceedings with devotional exercises, and the Rev. Mr. Beverley addressed the Council and the Rev. Mr. Wellwood offered the prayer.

His Honour, Judge Vance addressed the Council and remarked on the few changes in the County Council for the year 1925. He was glad to see some old members, returned, especially some Ex-Wardens whose experience should be of great benefit to the County.

The County would be confronted with the problem of keeping down taxation and was sure their Legislation would be in its best interests. He referred to the increased cost of education. Roads, Public Health, Care of the Feeble Minded, and many other extra demands for taxation. If the average rate-payer knew of the problems of the Councillors their criticisms would not be so severe.

He referred to the presences of the ladies, and was glad to know they were taking an interest in Municipal affairs.

His Honour, thanked the Members of the Ministerial Association for their presence and remarked on the appropriatness of their remarks.

The Town of Orillia inaugurated a precedent by the Council, Board of Education and other governing bodies attending divine worship in a body.

His Honour again congratulated the Warden and wished him and the Council a prosperous and pleasant year.

The Warden then took the Chair.

He had the friendliest feelings towards his friend Mr Williams and the result was in doubt until the last vote was cast. He asked for the co-operation of the Members of the Council in transacting the business of the County for the present year. His best efforts would be used in looking after the welfare of the County. He appreciated the advice and words of encouragement given by his Honour Fudge Vance and the Ministerial Association.

The Warden appointed Councillor Rusk , Chairman and Councillor Hambly, Secretary and the Reeves of the various Municipalities as a striking Committee to name the standing Committees for the present year.

Mayor Craig and Ex-Wardens Coomes, Eplett, and Banting being in the Chamber the Warden requested them to take seats on the dias.

Mayor Craig congratulated the Warden on his Election and wished him and the Council a successful year during 1925. He congratulated the Members on their Election and welcomed the new Members to the Town.

Ex-Warden Eplett was pleased to be present. He was not a representative from his Municipality this year, but was pleased to see Mr. McKinley elected Warden.

Ex-Warden Coombs congratulated the Warden and referred to the fact that he was relieved from the responsibility of the Office and asked the same support for Warden McKinley that was accorded to him.

Ex-Warden Banting was impressed with the appropriate words of the Ministerial Association and his Honour, Judge Vance. He referred to the fact that the Warden was only one cog in the machinery of the County Council, each member also had a responsibility. He wished them all a prosperous year.
