MINUTES

Of the November Session, 1929, of the Minicipal Council of the County of Simone.

Council Chamber, Barrie.

Monday, November 25th.1929.

The Council met pursuant to the adjournment at the June Session.

The Warden in the chair.

All the Members present except Councillors Hawkins, Smith, Spicher, Bates and Caswell.

The Minutes of the last Meeting of the June Session having been printed and distributed, were taken as read.

The Warden expressed his pleasure at again meeting the Council in Session for completing the work of the year.

Considerable progress has been made in road construction. Some power road machinery, maintainers and graders have been in operation under the supervision of the Engineer and the Road Committee. Maintainance is a very important part of the Road programme of to-day.

He referred to the serious illness of His Honour, Judge Ross, and voiced the sentiments of the Council in hoping he would have a speedy recovery.

He stated that the new Registry Office was nearing completion. It had a pleasing appearance and should accommodate the records of the County for many years to come. He believed the work of the contractors, Messrs Bath and Anderson, was satisfactory.

The County of Simcoe Exhibit at the Canadian National Exhibition was a success and many favourable comments were made concerning it, and it was a good advertisement for the County. The campaign to improve the quality and sample of the potato industry in the County was getting good results already. Inquities were being made for No.1.grades, and the same were competing for first place with New Brunswick and other eastern potatos, and the Exhibit at the ing Royal Winter Fair , being held in Toronto at the present time, was bring, the Ontario product prominently to the attention of the consumer.

He mentioned the fact that Clifford Baldwick, a Simcoe County boy, through his success in stock judging, had earned a free trip to the Old Country, which brought honour and distinction to himself and the County. Incidently, a considerable amount of the credit was due to the efforts of Stewart, Page, the Agricultural representative for North Simcoe.

He referred to the case of Archie McNabb of Vespra, who was instrumental in securing the arrest of Ernest Edward Ream, and would suggest that the Council make a recognition of his act in a tangible way.
