He congratulated the "arden on his election and wished him and the Council a successful year during 1931.

The Warden then took the Chair.

The Rev. J.S.Shortt, on behalf of the Barrie Ministerial Association, addressed the Council and congratulated the Warden on his election and wished for the Council and the County of Simcoe a successful year and felt sure that their deliberations would be conducted in harmonfy and good will.

He referred, in olden times, to the conflicts between Church and State, but happily these times were now long past, and in his opinion all business should be conducted with the highest regard to the welfare of County, Province and Dominion.

The Rev. Mr. Black offered prayer.

Warden Glover addressed the Council and expressed his deep appreciation at being slected Warden by acclamation.

It was thirty one years since the Township of Nottawasaga had one of it's representatives as Warden, and on behalf of the electors of his Township, he thanked the Members for electing him.

This will be an important year in the history of the County, as Simcoe holds a



very important position in the Province of Ontario, both agriculturally and geographically . We, with all parts of the world were passing through a critical time and he would ask the Members and the different Committees to be as economical as possible having regard for the welfare of the County. He would not like to see the County rate increased.

He referred to the illness of Mr. W.A.Tom and also the bereavement of Councillor Ronan in the death of his Mother, and of Councillor Morley in the death of his Father., and suggested that the Council pass a resolution of sympathy.

Mayor McCuaig of Barrie, and Ex-Wardens Davis and Eplett being in the Council Chamber, the Warden asked them to seats on the dias.

Mayor McCuaig was pleased to be here at the first Meeting of the Council and extended the freedom of the Town to the ^Members and especially to the new members to whom he extended a cordial welcome. He congratulated the ^Warden on his election and was glad to hear him urge the Council to practice economy, although if Councils cut down all expenditure possible it would make very little difference as the bulk of the taxes were uncontrolable.

Exwarden Davis expressed his pleasure at being present to have the opportunity to congratulate the Warden and referred to the fact that just five years ago he was in the same position.

He appreciated the services the ^Warden had given to the County during the term he had represented the Township of Nottawasaga. In his opinion, economy should be practiced on account of the difficult times through which we were passing. The County of Simcoe had a good position on account of having no debenture debt.

ExWarden Eplett congratulated the Warden and stated that it was eight years since his election to the "arden's chair, although on looking hack it did not seem half that time.

He expressed the hope that the Warden and the Council would have a prosperous year.
