FIRST DAY

Council Chamber, Barrie, June 12th. 1933.

The Council met pursuant to the adjournment at the January Session.

The Council would be asked to consider the equalized assessment of Port McNicoll and would suggest that the question be referred to the Standing Committee on Equalization.
