MINUTES

Of the November Session, 1933, of the Municipal Council of the County of Simcoe.

FIRST DAY

Council Chamber, Barrie, November 20th.1933.

The Clerk called the Council to order and explained that owing to the unavoidable absence of Warden Isaac Scott, through illness, it would be necessary for the Council to appoint one of their members to act as Warden for the term of the Session or until such time as the Warden recovers.

He referred to the death of Ex-Warden Joseph Wright of Beeton, who was the Warden in 1893, just forty years ago this present year, and also to the death, since the June Session, of Ex-Councillor, Charles Denney, a former Reeve of Essa.

He also regretted the serious illness of Ex-Wardens Banting and Cunningham and trusted that they would soon have a satisfactory recovery.

Reeve Asselin of Tiny, and Reeve Tudhope of Orillia had suffered bereavement by the loss of relatives since the June Session. The former by the loss of a daughter, a young girl thirteen years of age, and the latter by the loss of a brother.

He asked for nominations for an Acting Warden until such time as the Warden was able to resume his duties.

The Acting Warden thanked the Members for the honour conferred on him, and stated that all the Members would miss Mr. Scott, and each one regretted with himself that he was unable to preside at this session, as from his wide municipal experience he was a guide in transacting the business of the Council.

He asked for the co-operation of the Members, and requested that all references to the different Committees, and all business to be brought before the Council, be in at tomorrow's session

He was not familiar with the financial conditions or the amount of uncollected County levy. He requested the Members to be careful in the matter of expenditure.

G.S. Dudley. Solicitor for the Town, stated that Midland had spent a considerable amount on improvements in the Town during the good years and these obligations had to be met. If Midland could sell it's debentures it would be able to meet it's obligations, and requested the Council to favourably consider the request.

Mayor Roebuck expressed the opinion that Midland would be in a position to warry on if the Town could sell the debentures, which they were asking the County to guarantee. Relief coming in from outside cost the Town considerable sums.

Councillor Dutton on behalf of Robert Craig, asked for permission to hang a picture of his father, the late Ex-Warden Arthur Craig, in the Council Chamber.

Councillor Dutton explained the stand taken by the County Road Committee reit's proposition on paving on the Provincial Highway.

Councillor Drinkwater inquired if it was the custom of Reeves to sign Municipal cheques.

Councillor Jebb stated that the Reeve did not sign cheques in the Township of Tecumseth. An order sheet was prepared and signed by the Reeve and the Clerk for the payments made and the Treasurer issued his cheques accordingly.

Mr. W.A.Boys, K.C., County Solicitor, addressed the Council on the subject of uncollected taxes, stating that a judgement of Justice McEvoy's was to the effect that where taxes were returned as unpaid, where there were chattels, which could have been distrained, and the property afterwards sold for such arrears of taxes, the sale could be set aside. In his opinion (Mr.Boys) this would work a hardship in many cases. Where poor crops, poor prices, illness, or other causes made it impossible for an individual to pay his taxes when due.

He suggested that the Council take into consideration the advisability of requesting the Attorney General to have legislation enacted to have taxes remain as a lien on the land, regardless if distress had not been imposed.

The Clerk reported that the Hospital account of Ruby Taylor, a patient at the Mountain Sanitaruim, Hamilton, had not been paid as instructed at the June Session, as the County Solicitor had advised that the County did not receive notice at the time of admission and was not liable for the hospital maintenance.

The Hospital was notified accordingly, and has not since insisted on payment.

He reported that the hospital maintenance of ane Robertson, who had been a patient in the General and Marine Hospital, at Collingwood, at various times, and which had been paid by the County, had been recovered and half the amount of the account had been returned to the local Municipality.

Councillor Jebb stated that at the present time there were one hundred and fifteen inmates in the House of Refuge, Beeton, and some Municipalities were endeavouring to send undesirables to the House, and in one case a young child. He advised the Members to be very careful in the class of inmates they committed to the House, as under the present conditions, it would be filled beyond capacity.

The Honourable William Finleyson, Minister of Lands and Forests, addressed the Council and stated that he liked to meet the Members in Council at least once a year, and keep in contact with them.

The duties of Councils were governed by statute, and such statutes could be amended when deemed advisable to do so.

He stated that the question of the collection of taxes was under consideration by the Legislative Committee of the Ontario Legislation and if the Council had any particular amendments to make or any suggestions to make regarding this matter, to advise this Committee of any suggestions, and they would be considered, and an opportunity be given for representation be fore the Committee.

He felt that with co-operation and all pulling together, Canada and it's Provinces and Municipalities would come through this depression, and already bright spots could be seen by an improvement in prices in farm commodities, and in other lines, and he expected a gradual, through perhaps slow, improvement.
