MINUTES

Of the June Session, 1936, of the Municipal Council

Of the COUNTY OF SIMCOE

FIRST DAY

Council Chamber, Barrie, June 15th, 1936.

The Council met pursuant to the adjournment at the January Session.

The Warden in the chair.

All the members of the Council were present but Councillor Smith.

The Minutes of the last meeting having been printed and distributed were

taken as read.

The Warden addressed the Council and referred to conditions in the County. He stated that the spring season had been backward and that vegetation was injured by early frosts, but with sufficient moisture and favourable weather recently a great improvement had taken place and the present gave promise to a bountiful harvest.

He referred to the death of Ex-Warden Scott, one of the best municipal men the County had produced. In his death his community and the whole County suffered the loss of one of the most outstanding citizens.

During the year the County also suffered the loss of Ex-Warden Tom, W. Mackay, Ex-reeve of Creemore, and A. C. Robins, Ex-reeve of Coldwater. In the latter case, Mr. Robins was a young man in the prime of life and furing the time he was a member of the Council he showed outstanding knowledge in Municipal affairs.

The financial condition of the County showed improvement from last year and he quoted statistics in support of this as compared with one year ago.

The new County Road Superintendent was showing that he was obtaining thorough knowledge of the County Road system. He was giving his full time to his work and was mastering all branches pertaining to the roads.

With reference to the Moose River mining disaster in Nova Scotia which created so much interest throughout civilization, he stated that the wife of Mr. Scadding was a Simcoe County girl, the daughter of Henry Smith, Flos township, and a neice of Thos.

E. Smith, a former Reeve and the present Clerk of that Township.

He requested the members to be prompt in attendance at all meetings of the Council and Committees, and that all resolutions be prepared and presented at an early date.

A deputation from the Township of Tossorontio waited on the Council and asked the County Road in that Township be changed from going north from Everett on Concession 5 to Concession 3. The change would give direct traffic from Provincial Highway No. 9 to Creemore and would equally serve all traffic, and would avoid four level crossings. There would be no new bridges to build. Mr. E. Halbert was spokesman for the depuation and was supported by eight other ratepayers.

Councillor Carlton produced a drawing showing the two routes and described the level railway crossings and culverts and the physical conditions through which the roads pass.

Another deputation from the same Township appeared in support of the present designated road. Mr. Thomas Irwin, Clerk of the Township gave some reasons why the road should not be changed. He stated that the present County Road was formerly a part of the County Road system and it served villages, business men, butchers and bakers more than the third concession. He believed that the present road was cheaper to build and maintain than the one asked for. He was supported by seven other rate payers of Tossorontio.

- 1. Therefore be it resolved that this County strongly urge upon the province that the Municipal Act be amended to permit Councils a greater voice in expenditures of School Boards.
- 2. That school requisitions be paid over in proportion only to the annual total amount of ordinary taxes collected, and that in event of an overdraft the Board be required to absorb same in their next year's estimates through reduction in controllable expenditures.
- 3. That where differences of opinion exist between Councils and Boards of Education which cannot be adjusted to the satisfaction of both bedies, that the Act provide for the appointment of one member from each body to meet with a representative of the Department of Municipal Affairs for arbitration and final settlement with a view to establishing estimates and expenditures on the basis of the annual ability of the tax-payer to pay rather than maintaining salaries or other controllable expenditures on a comparable basis with other municipalities.
- 4. That we further consider it advisable that the Mayor or Reeve of each Municipality be a member ex-officio of Boards of Education.
- 5. And that the Clerk be instructed to send copies of this resolution to all County Appointees, Chairmen of Boards of Mucation, Albert E. Smith (President of the Ontario Mayors Association), Dr. L.J. Simpson (Minister of Education), H.L. Cummings (Dept. of Municipal Affairs), and Mayor M.M. McBride, Brantford.

He congratulated the County for what had been accomplished by reforestry and recommended that the County prosecute this work more vigorously than it had to the present. It was a solid and fine investment where all the factors were balanced. It also added beauty to the country.
