The Warden addressed the Council and welcomed the members to the November Session and was glad to report there had been no deaths since the last session.

He was glad to report that the County was in very good shape financially. He referred to the costs of Old Age Pensions, Mothers' Allowance, Childrens Shelter, House of Refuge and Hospitalization.

He stated the County Road Committee and Engineer would keep the expenditure this year on the County Road System within the amount appropriated. This is the first year for a long time the County Road Committee had kept within its estimates.

He referred to the progress of the campaign to make the County of Simcoe a T. B. free area. He urged that all parts of the County that had not already completed the canvas and made a report, to do so as speedily as possible. If the Canvas were not soon completed and reports presented in the near future, it might be two years before the testing could be commenced.

He referred to the Provincial Plowing Match and suggested that an effort should be made to bring it to the County of Simcoe. These matches bring many visitors and would be a good advertisement for the County.

He was satisfied the farms were in better position than a year ago and seemed to be more satisfied.

He referred to the deaths of five citizens of the Village of Victoria Harbour who lost their lives at the sinking of the "Sand Merchant" in Lake Erie.

He stated that for the last three years the Orillia Lacrosse team had won the Dominion Championship, and he would like to see their achievement recognized.

A Deputation appeared before the Council composed of, Mr. Higgins, Craighurst; Rev. Mr. Newman, Craighurst; and Mr. Chapman, Hillsdale, asking that the County Council request the Department of Highways of Ontario to take over the Penetang Road from

Crown Hill to Waverley as a part of the Provincial Highway system.

Mr. Higgins addressed the Council and referred to this road as an old historic road and thought it should be assumed by the Highway Department, as a Provincial Highway.

Rev. Mr. Newman stated he had to use the road from Craighurst to Crown Hill for his Sunday Services and often he could not do his Sunday work on account of the road not being cleared for motor traffic.

Mr. T. R. Chapman, Hillsdale, stated that commercial traffic was a year round traffic and he was asking the Council to recommend to the Highway Department that it be made a Provincial Highway.

The Warden assured the Deputation that the Council would seriously consider the request.

He was opposed to any change from the present system because a large part of the relief would have to be paid indirectly by rural municipalities, and, in his opinion, the Council should take some action to express its views in this regard.

AND WHEREAS money is now borrowed by the municipalities to pay their county levy in order to take advantage of the 2% discount offered for early payment, and they have also to provide the money for the pay rolls above referred to,

THEREFORE BE IT RESOLVED that any urban municipality may remit along with, in lieu of cash in their annual levy to the County, proper certified pay-rolls and accounts which have been spent on such streets or roads, as agreed up to the amount so granted such urban municipality for such purpose.

He trusted that their sojourn in the County Town had been pleasant.

The Warden called on Councillor Palmer to give the members of the Council
a short report of his trip on the Vimy Pilgrimage the past summer.

Councillor Palmer stated the trip was a very pleasant one. They embarked at Montreal and had a spendid trip with calm weather and landed at Antwerp in Belgium.

He stated that for scenic grandeur no country in the world surpassed

Canada and Canadians could all be proud of their own country.

He referred to the changes in the war area at the present time to what it appeared during the war. Great improvements and restorations had been accomplished.

The Vimy Memorial was a large structure, 200 feet square at the base and 250 feet high.

The unveiling ceremony on July 20th was an occasion never to be forgotten.

He described farming conditions much improved since war days and there

was great improvement in the roads and at the present time there was a large number of

paved roads.

He told of the return to England and explained the arrangements made in London for the entertainment of the pilgrims which included a garden party at Buckingham Palace where the King met them and mingled and chatted with them and afterwards addressed them shortly.

He explained the visit to Paris as guests of the French Government.

He appreciated the kindness of the Council to Mrs. Palmer and himself which assisted them in perhaps more fully enjoying the trip.
