The Warden addressed the Council and expressed his appreciation at seeing all the members present at the opening day of the Session.

He stated that the Special Committees would report in a day or two and he understood the Special Committee on Reforestation had a report prepared for today. He expressed

His Honor, Judge Holmes, had recently made the statement that the roads under the control of the County Engineer and County Road Committee were much improved in recent years, and both the Engineer and the Committee were to be congratulated.

The financial condition of the County was quite sound, and all Committees this year had lived within their estimates.

The chartered accountants would cost the County this year \$725.00 and this appears favourable with the cost to the County for the same work in former years, as the Financial Statements which, in former years, were printed annually, would not have to be printed for this year. The work of the chartered accountants was satisfactory and was approved by the Department of Municipal Affairs.

The situation in Midland as regards its debentures was satisfactory, and at a meeting with the Council of Midland and the Department of Municipal Affairs tonight in Midland, a scheme would be adopted which, it is thought, would be satisfactory to the bond holders. It is expected that the time for the payment of the debentures will be extended. The County Council could be asked to express its approval if the scheme appeared to be in the best interests of the County.

The accident on the County Road last June, which resulted in the death of william Campbell, of Duntroon, might be the cause of litigation and the County might be called on to pay some costs if damages were awarded an amount over and above that covered by the Highway Insurance Policy.

Ex-Warden Drinkwater being in the Council Chamber, the Warden invited him to a seat on the dais and was asked to address the Council.

He referred to the excellent year the County has had and although in some parts of the County the returns from agriculture was not all that was anticipated early in the year, still on the whole there was cause for thankfulness.

the cause for accidents on the Municipal roads was the driver's fault, and the municipalities in those cases should not have to pay damages.

He congratulated the Council and the County Property Committee on the improved appearance of the Council Chamber, the Court Room, and the main corridor, and stated the new decorations in the chamber added to the appearance and comfort of the chamber.

Moved by Councillor Cox, seconded by Councillor Johnston, and ordered, That the Committee on Railways and Canals instruct the Clerk to write Mr. Rogers, Superintendent of Railways at Allandale, protesting against the smoke nuisance caused by trains at the village of Washago and that immediate steps be taken to curb this nuisance which would greatly be appreciated by residents of said village.

Moved by Councillor Neff, seconded by Councillor Brack, and ordered,

That the Roads and Bridges Committee consider the advisability of paying
to the Women's Institute at Nottawa the usual grant of \$15.00 for the upkeep of light on
the County Bridge.

Moved by Councillor Neff, seconded by Councillor Patton, and ordered,

That the Roads and Bridges Committee consider the advisability of requesting the Department of Highways of Ontario to assume as part of the Provincial Highway System
the following County Roads: (1) The townline between Sunnidale and Nottawasaga townships
from Highway 26 to Wasaga Beach, a distance of 32 miles, (2) That portion of Byrnes Avenue
commencing at the townline between Sunnidale and Nottawasaga townships and continuing
westerly to its intersection with Highway 26, a distance of 12 miles.

November 25th, 1937.

Moved by Councillor Livingstone, seconded by Councillor Lawrence, and ordered,

That the Standing Committee on Railways and Canals consider the advisability of memoralizing the Minister of Railways of the Dominion Government that steps should be taken immediately to eliminate the danger our railway crossings on the boundary line between Simcoe and Peel near Tottenham, as both railways cross the new Provincial Highway at this point within a distance of eighty some feet of each other, and is a very dangerous crossing and that a copy be sent to each of the local members of the Federal House.

Moved by Councillor Dutton, seconded by Councillor Benson, and ordered, That the Council do now adjourn to meet at 2 P.M. this afternoon.

The Council resumed, as per adjournment, at 2 o'clock.

The Warden presented the resignation of J.P. Davis as County appointee on the Collingwood Board of Education.

A deputation representing the Ontario Plowmen's Association appeared before the Council concerning the International Plowing Match for 1938.

asked Mr. J. A. Carroll, Secretary-Manager of the Plowmen's Association, to introduce the members of the deputation. He stated this Plowing Match has grown from a few teams and one tractor, 25 years ago, to 625 entries at Fergus this year. This was the largest event of its kind in the world and was attended by more than 100,000 visitors and had the effect of promoting improved methods in agriculture. The County of Simcoe had not had a match and his Committee, sometime ago, had visited eight locations and had come back today to give some of them another inspection. He called on Mr. Mckae, President of the Association, to address the Council.

Mr. McRae stated they had made an inspection today of some locations in the north and some in the south part of the County, and they had found snow in the north and dust in the south. Simcoe should do as well as any other counties and the locations they had visited were quite suitable and nothing could do more to advance agriculture than good plowing and a well attended Plowing Match.

Mr. J. J. Duffus, M.P., Peterborough, stated the Plowmen's Association and plowmen were anxious to go to Peterboro again but he thought next year's Match might come to Simcoe. It was necessary to have some large centre at not too great a distance from where the Match was held, because the plowing match was no small affair. There would be 300 acres required for actual plowing and from 140 to 175 teams of horses loaned for the Match and nearly 100 tractors. The Match was of inestimable value if farming was to be prosperous and the benefits of the Match were lasting.

The spirit of the people makes the Match a success and there would be needed 60 to 70 volunteers to work hard, without pay, to make the Match a success.

Mr. Tierney of the Ontario Plowmen's Association, who is responsible for the selection of the location of the Match, stated that his County of Leeds, in the vicinity of Brockville, was anxious to again have the Plowing Match, but representatives from Simcoe, at the annual meeting of the Association in February, 1937, had invited the Association to hold the 1938 Match in Simcoe. The Committee had seen sufficient land in different localities that had the requirements for a Plowing Match.

Col. George Little and Mr. Clark Young, Treasurer of the Association, also spoke to the Council.

Mr. Carroll stated the Committee would not make any committal as to and definite site as several good locations had been inspected, enough to insure a good match. One thing essential was to get enough good land in the smallest area so that visitors would not have to go too far to see the plowing in the different classes.

The Warden thanked the Committee and assured them that the County Council, the Town of Barrie, and the citizens generally, would join in giving the project heartiest support.

That Dr. W. M. Blakely be appointed to the Board of Education of Colling-

wood to fill the unexpired term of Dr. J. P. Davis, who has resigned.

Moved by Councillor Todd, seconded by Councillor Lawrence, and ordered, That the spendid success of the exhibitors from this County at the Royal Winter Fair in the different classes of horses, cattle, hogs, poultry, silver fox, mink, apples and potatoes should be recognized by this Council.

Therefore, the Clerk of the County is instructed to send to each exhibitor a letter of congratulation from this council.

Moved by Councillor Lawrence, seconded by Councillor Neff, and ordered, That the Roads and Bridges Committee consider the advisability of requesting the Department of Highways to take over that part of the County Road No. 7 as a Highway, westerly from Angus to New Lowell, also a continuation of County Road No. 9 from Hew Lowell to the boundary between Gray and Simcoe Counties.

- Of the Standing Committee on Roads and Bridges was presented and read. REPORT NO. 7 -Moved by Councillor Hickling, seconded by Councillor Fleming, and ordered, That the report now read be adopted.

Mayor Khol of Collingwood being in the Chamber was invited to a seat on the dais and asked by the Warden to address the Council.

Mayor Khol stated that last week the Collingwood Terminals Limited informed the Council of Collingwood that they would default the payment of the debentures due on December 1st, 1937.

In his opinion there was no cause of alarm, and suggested that a Committee be appointed by the County Council to workiwith a Special Committee of the town of Collingwood

and predicted that everything would work out satisfactory.

Moved by Councillor Barker, seconded by Councillor Hickling, and ordered, That Councillor Cunningham, Lawrence, and the Warden be a committee to look after the County of Simcoe's interests regarding the Collingwood elevator and the default of their bonds, and also the County Solicitor, in the event of it being necessary, to call such Committee.
