MINUTES

Of the June Session, 1938, of the Municipal Council Of the COUNTY OF SINCOS

FIRST DAY

Counsil Chamber, Barrie, June 20th, 1938.

The Council met pursuant to the adjournment at the January Session. The Warden in the Chair.

The Clerk reported he had received notice from the Clerk of Tecumseth of the election of W. J. Ritchie, Beeton, R.R., as Deputy-Reeve of the Township in the place of James Henderson, deceased.

Also from the Clerk of the Township of Adjala of the election of Earl Wilson as Reeve of the Township in the place of Wilmer Palmer, resigned.

All the members were present but Councillors Tissington and Johnston.

It is with considerable pleasure that I greet you, said Warden Patterson in addressing the members of the Council, to the June Session this year and to see you are looking as if you were in the best of health.

Since our session in January the County has suffered the loss through death of some of its preminent citizens; Mr. James Henderson, Deputy-Reeve of Tecumseth, who was unable to attend the January Session through illness, was called by death shortly afterwards. Councillor Henderson was a very capable and popular member of the Council and the Township of Tecumseth and the County suffered a distinct loss in his death.

In February, Mr. W. A. Boys, County Solicitor, was also called by death. He was on a trip with Mrs. Boys to the warmer climate of the Southern States and although not enjoying the most robust health the last few years the call came suddenly.

He was appointed County Solicitor at the June Session in 1922 on the death of Mr. W. A. J. Bell, and previous to that had served for years in the County Council, having been Warden in 1907. He had also served on the Council of the Town of Barrie, being Mayor for two terms.

The County also suffered the loss of Mr. George Vickers, Registrar of Deed, Mortgages, etc. He was well known in the Town of Barrie and in the County, having conducted a successful business in the town for many years. He was appointed Registrar in 1934 June 20th, 1938.

He was well known as a lover of flowers and won many awards in the Province especially with gladioli.

Recently, our colleague, Walter Middleton, Deputy-Reeve of Flos township, suffered the loss of his only son, Frank, under very distressing circumstances.

I have had expressions of sympathy of the Council extended to the bereaved friends.

We welcome Mr. W. J. Ritchie, Deputy-Reeve of Tecumseth and also Mr. Earl Wilson, elected Reeve of Adjala township, to membership in the Council.

We are also extremely sorry to hear of the illness of Mr. J. S. Drinkwater but are glad to know that he is improving and hops he will have a speedy recovery.

It is many years since there were such prespects for good crops in the County as there are at the present time and it is a pleasant sight to drive on our roads and view the meadows and fields of grain that are growing so rapidly. It is to be hoped our farmers harvest good crops at good prices as it will mean improved conditions for all. It was my privilege recently to have a trip through the southern part of

the County and I was pleased with the appearance of the House of Refuge Farm and also with the farm bought by the County recently.

When adjournment was made at the January Session it was expected a Special Session would have to be called in March or April to ask your approval to the refinancing of Midland's debentures. When terms were finally arrived at it was decided a Special Session could be avoided and you will be now asked to approve an arrangement for the refinancing of Midland's debentures which has been completed. Mr. A. B. J. Gray of the Department of Municipal Affairs will attend the Session tomorrow to explain the terms of the refunding.

You will also be asked to consider the best course to adopt in connection with the default in payments of principal and interest of Collingwood Elevator Debentures, due December 31st, 1937, and June 1st, 1938, by Collingwood Terminals Limited. The payment of these debentures have been guaranteed by the County.

The Committee appointed to inquire into the application for the erection of Wasaga Beach into a Police Village will present a report on their findings. A deputation from the Beach wishes to be heard in this connection and Tuesday morning at 9:30 o'clock has been named to hear the deputation.

The Committee on Reforestation has been active since the January Session and has been responsible for the establishing of school reforestation plots in all of the Townships in the County. These plots will eventually be a great asset to the County and will encourage and make the pupils interested in tree planting.

SECOND DAY

CouncillChambers, Barrie, June 21st, 1938.

The Council met pursuant to adjournment from yesterday's session. The Warden in the Chair.

All the members were present.

The Minutes of yesterday's session of the Council were read and adopted. The Clerk read two communications from H. Kitcher, Toronto, and R. A. Wharton, Toronto, asking that their properties be included in the proposed Police Village

area at Wasaga Beach.

The Warden stated that at the January Session a Committee had been appointed to obtain information regarding the area that had been included in the request for the erection of a Police Village at Wasaga Beach. The Committee had presented two reports yesterday, which were adopted, but as there was a deputation in the interest of the Police Village to wait on the Council he asked the Clerk to again read the reports.

The Clerk was also asked to read the petitions for and against the erection of a Police Village.

The Warden then asked Mr. R. R. Goldsmith, Wasaga Beach, to address the Council in support of the petition for a police village. Mr. Goldsmith outlined what the benefits of a Police Village would be to the petitioners. Councillor Dutton enquired if there was a plan of the area included in the petition and was informed that there had not been a plan prepared.

Mr. A. J. F. Sullivan, Stayner, was asked by the Warden to speak on behalf of "Oakview Beach". Mr. Sullivan stated he would not have so much to say as he was now informed that "Oakview Beach" was not included in the police village area. He explained to the Council that "Oakview Beach" was not included in the police village area. He explained to and the police. The Council had given reasonable attention to the streets and the police had given all the protection necessary. He could not see that there would be any benefits from a police village. In his opinion there would be increased taxation as a certain element would be demanding additional services.

Mr. McCracken, Wasaga Beach, objected to some statements made by Mr. Sullivan and was of the opinion that with the same taxation there would be better results. June 21st, 1938.

Councillor Spicher stated that Wasaga Beach had not contributed any funds to the Treasury of the Township of Sunnidale but many times, during the years of the depression, funds had to be taken from taxes paid by the farming sections to pay the County levy on the Wasaga Beach area. He would be pleased if the whole Wasaga Beach area were removed from the township.

Councillor Toner, Reeve of Flos, stated that Wasaga Beach had cost the Township of Flos more for their roads and streets than they had contributed but the township had always given them every consideration and was not anxious to lose any part of the township in the proposed Police Village.

Moved by Councillor Grant, seconded by Councillor Gratrix,

That the petition asking for the erection of Wasaga Beach into a Police Village be held over until later in this Session and in the meantime a blue print be prepared.

On a show of hands the motion was declared carried.

That the petition of ratepayers of Wasaga Beach for the erection of a Police Village be granted and that a By-Iaw be presented later in the session carrying out the same after the necessary formalities have been complied with.

He stated that last year \$1000.00 had been set aside for Special Committees and \$1,400.00 had been paid.

This year \$1,400.00 had been settaside for Special Committees and already \$1,100.00 had been paid leaving only \$300.00 for the balance of the year and he had instructions from the Warden and Chairman of the Finance Committee to not make payments to exceed any of the estimates. If an extra grant was required by the Special Plowmen's Committee the Chairman should be authorized to issue an order for it.

The hospital accounts for indigent patients were increasing but, if as indicated by the Ontario Department of Health that the cost of consumptive patients would be assumed by the Province, it would be a considerable reduction in these accounts as the consumptive accounts for May was in the neighborhood of \$1,800.00.

The County levy of all the municipalities was paid up excepting Tay and Tiny.

The County Road Committee to date was keeping within its estimates and he was satisfied the County would finish up the year with a supplus.

Considerable discussion took place over the costs of the Plowing Match Committee and the Council was assured by the Chairman and members of the Committee they were meeting with good success and co-operation and they did not anticipate the County would be called on for any extra grant.

Warden Patterson stated Mr. A. J. B. Gray of the Department of Municipal Affairs was in the Chamber to report on the refinancing of Midland debentures.

The Warden invited Mayor Mackie of Midland to a seat on the dias.

Mr. Gray explained that an agreement had been arrived at for the refunding of Midland's debentures which, in his opinion, was a fair one, and which met with general approval. A resolution setting out the terms of the agreement will be presented for the approval of the Council. A By-Law would be prepared and the Council would be requested to give it their approval either at or before the November Session.

With reference to Collingwood debentures Mr. Gray explained that arrangements were under way to have the Collingwood elevator debentures that were due December 1st, 1937, paid so that all Collingwood's debentures would be paid to date and then they would be placed on the same basis.

It was his suggestion that two directors from the County had been nominsted to Collingwood Terminals Limited.

Mayor Mackie addressed the Council and was well pleased with/arrangements regarding Midland's debentures and appreciated the co-operation received from the Department and the County.

Councillor Cunningham stated he was very pleased with the arrangement and solution of Midland's debentures and he wished other municipalities had the same arrangement as regards interest rates on their debentures.

Moved by Councillor Cunningham, seconded by Councillor Thompson, and ordered,

WHEREAS Debentures of certain Corporations in the County of Simcoe, including the Town of Midland, are in default and certain of such debentures have been

AND WHEREAS a refunding plan in respect to the debentures of the Town of Midland, guaranteed by this Corporation, has been arrived at, and approved of by the Debenture Holders Protective Committee, full particulars of which plan were submitted to a Committee of this Corporation above referred to, and a Committee of the Town of Midland, on May 17th, 1938, and are set out in the Minutes of such meeting attached hereto, which are hereby declared to be and do form part of this Resolution.

Meeting of the joint Committee of the town of Midland and County of Simcoe re refunding of Midland's debentures.

The following were present: Warden Patterson; Mr. Boys, Solicitor; Mr. Cunningham; Mr. Simpson; Mr. Benson; Mayor Mackie; Mr. A. J. B. Gray; Mr. Coleman; Mr. King. Mr. Gray outlined the proposed basis of refinancing Midland debentures

as follows:

The debentures to be extended from January 1st, 1938, for a period not exceeding 35 years, to bear interest at contractural rate to original date of maturity, and $4\frac{1}{2}$, thereafter such debentures as are now guaranteed by the County to bear the County's guarantee.

Arrears of interest to be calculated at contractural rate to due date and thence at 45% to December 31st, 1937, and be considered as fully liquidated on payment of 90%; for example a \$1000.00 debenture due in 1936, bearing a rate of interest of 5%, would be settled on the following basis:

The municipality to be under a modified form of supervision under the Department of Municipal Affairs. The Corporation of Midland to bear the expense of the Bondholders Committee relative to refinancing.

AND WHEREAS it is deemed advisable that the date of adjustment should be changed from January first 1938 to June 30th, 1938, but in all other respects the said refunding plan be approved.

BE IT THEREFORE RESOLVED BY THE COUNCIL OF THE CORPORATION OF THE COUNTY OF SIMCOE, as follows:

1. That the refunding scheme in respect to the debentures of the Town of Midland guaranteed by the County of Simcoe, as described in the said Minutes attached hereto, be approved, except that the date of adjustment shall be June 30th, 1938, instead of January first, 1938, and the exclusion of the portion dealing with High School Debentures.

2. That the County Solicitors be and they are hereby authorized and instructed to do all things necessary to carry into effect the said refunding scheme.

3. That the Warden be and he is hereby authorized to call a special session of the Council of the County of Simcoe if it is deemed necessary so to do, in order to pass such By-Laws or Resolutions as may be necessary to put such refunding plan into effect, and that if such special session is not necessary the same will be dealt with at the next Session of this Council.

4. That any further costs which may be necessarily incurred by this Corporation to carry out the intent and meaning of this Resolution, including legal costs and Committee costs, be paid by the Town of Midland, and that all costs incurred by this Corporation to this date be paid by this Corporation.

The Warden explained that a deputation from the Grey and Simcoe Foresters Regiment, composed of Col. McDonald, Capt. Beller and Capt. Raikes, wished to address the Council.

Col. McDonald, O.C., Grey and Simcoe Foresters Regiment addressed the Council and referred to the amalgamation of the two militia units of Grey and Simcoe. He stated that units had been well supported by the two Counties and he was requesting financial assistance from the County as this time last year it was not necessary to ask for assistance but through the year it was found necessary to make an appeal and anything given would go to the men and not to the officers. He asked for a grant of \$300.00

Capt. Raikes stated the amalgamation was successful and there was splendid co-operation between the officers and N.C.O.'s and he was thoroughly appreciative of the assistance formerly given to the Simcoe Regiment and would respectfully request that the grant be continued.

Capt. Telford, Owen Sound, stated the amalgamation was doing good work and every effort would be made to keep up the splendid traditions of both regiments and asked for a grant to assist the men in camp.

FIRST DAY

Council Chamber, Barrie, November 21st, 1935.

The Council met pursuant to the adjournment at the June Session. The Warden in the chair.

All the members of the Council were present but Councillor Johnston.

The Minutes of the last meeting having been printed and distributed were taken

It is with very great pleasure I welcome you to the November Session, the final Session for 1938, and the last one over which I as Warden will have the pleasure of presiding.

It is with great regret we note the absence of Tom Simpson, our County Clerk, who was taken ill over a month ago, and is still confined to bed.
