FIRST DAY

Council Chamber, Barrie, June 12th, 1939.

The Council met pursuant to adjuarnment at the January Session. The Warden in the chair.

All the members were present.

The minutes of the last session of the Council having been printed and distributed were taken as read.

The Warden addressed the Council and welcomed the members to the June Session and was glad to see them all in their places.

On behalf of the members he welcomed Councillor Neff back to the Council after the serious illness which developed at the January Session. Also Councillor Horne who also had a serious illness. He was pleased to see them both at the session and trusted they had fully recovered. He also referred to the presence of the County Clerk who was absent, through illness, at the November Session, 1938, and the January Session. He was glad to see him able to resume his place as Clerk.

He referred to the prospect of a splendid erop throughout the County this year. The most oustanding event of the year was the visit of Their Majesties, King George and Queen Elizabeth, to Canada and the United States.
