Criminal Calendar from the Governor of the County Gaol showing that twenty-three (23) prisoners are confined there at the present time for various offences.

All the Branches of Patriotic Organizations in Collingwood were in hearty support of this endeavor.

In the last war the County contributed \$125,000.00 in one year for Red Cross and Canadian Patriotic funds.

Mrs. Gray, Collingwood, Regent of The Daughters of the Empire, referred to the work being done by the Local Organizations and expressed the hope that the Council would give sympathetic consideration to their request.

Councillor McLeod, Deputy-Reeve of Nottawasaga township, introduced a deputation from the Nottawasaga Plowmen's Association, composed of Mr. Donald Brown, Mr. D.A. Vancise, and John R. Smith.

Mr. Brown stated that last year a Branch of the Ontario Plowmen's Association had been organized in Nottawasaga and they were asking for a grant from the County to assist them in their work.

Councillor Todd, Chairman of the Federation of Agriculture of the County of Simcoe, introduced a deputation representing the Federation, composed of Mr. S. L. Page, Agricultural Representative of North Simcoe, and Mr. K. N. Morrison, Manager of the Copaco Plant in Barrie.

Mr. Page said that he was requested to present the case of the Federation and it was one of the largest organizations in the County. The movement commenced about 1935 as a Chamber of Agriculture in different Provinces. Peterborough County was the first to organize in this Province and Simose is the seventh and about fourteen Counties have organized up to the present.

The Organization was made in Simcoe County in January this year. Officers were elected at a County meeting at Midhurst, Springwater Park, on Saturday, June 8th, 1940, and a strong executive appointed.

He thought the movement was of sufficient importance to receive financial assistance from the Council and requested a substancial grant.

He stated that much could be accomplished by intensive co-operative effort in combating weed and insect peat, soil fertility and co-operation in the use of farm machinery, especially tractors.

A regular secretary should be employed and he would ask for a grant of \$1500.00 to \$2000.00 for this purpose.

Mr. N. K. Morrison stated the movement was for the purpose of assisting the individual farmer.

The statement is frequently made that farmers will not stick, but he does not believe it. There were over 500,000 farmers in Canada and over 8,000 in Simcoe County and he was satisfied that by organization much could be accomplished in their interests as was the case in other industries.

MINUTES

Of the November Session, 1940, of the Municipal Council Of the County of Simcoe

FIRST DAY

Council Chamber, Barrie, November 25th, 1940.

The Council met pursuant to the call of the Warden.

The Warden in the Chair.

All the members of the Council were present.

The Minutes of the last meeting of the Council having been printed and distributed were taken as read.

The Warden addressed the Council and welcomed them to the final Session of the year.

He referred to the illness of Councillor Toner and was very glad to see that he had recovered and was in his usual place in the Council.

He referred to the loss the County and the Province had sustained since the June Session in the person of the Hon. Dr. Simpson, Minister of Education since 1934, and the representative of Centre Simcoe since 1929. He was very popular and his early death is much to be regretted.

The season of 1940 would go into history as being most unusual on account of the unprecedented rainfall during the summer which made it extremely difficult to plant and harvest the season's crops.

The war situation did not appear any worse than at the June Session and in fact, in his opinion, the situation was improved but the members were well informed of conditions through the press and over the radio.

The report of the Sirois Commission on Dominion and Provincial relations, which was presented to the Dominion Parliament last May, will be considered at a conference in Ottawa on Jan. 14th, 1941, by representatives of the Dominion and the Provinces. The members of the Council might give this matter their consideration during the session and perhaps send a recommendation to the Conference.
