# of the Nevember Sessian, 1941, of the Municipal Council of the County of Simcee

First Day

Council Chamber, Barrie, Nevember 18th, 1941.

The Council met pursuant to the call of the Warden.

The Warden in the chair.

All the members were present except Councillor Harvey.

The Minutes of the June Session of the Council having been printed and distributed were taken as read.

The Warden addressed the Ceuncil and welcomed them to the Nevember Session.

"I am glad to know you are all hale and hearty.

It is with deep regret that I have to refer to the death, en the 13th instant, of Charles J. Gratrix, Reeve of Tay Township. About three weeks ago the Ex-Warden's Association held their annual meeting. He was president of the asseciation, and at the meeting appeared in the best of health and spirits.

After serving his township for many years as Reeve and Deputy-Reeve, his colleagues in the County Council elected him Warden of the County in the year 1929. Since that time he was absent from the Council for a few years, but returned as Reeve in 1937 and continued as such until his death.

You who have sat with him in this Council know his ability and sterling qualities, and the favourable financial position of Tay Township is due, to a great extent, to his wise direction of his Council.

It was gratifying to see so many members of this Council, as well as former associates, at his funeral. Few public men have as many meurners and sympathizers attend their funeral. It was a marked teken of the esteem in which he was held.

I would ask the Clerk to send a letter of condolence and sympathy from this Council to Mrs. Gratrix and family.

It is my sad duty also to refer to the less sustained, since the June Session, by Counciller Carlton through the death of his wife, and on behalf of the members I extend to him our sincere sympathy.

Since the June Session the Council has also sustained the less, through death, of Judge Holmes, Senior Judge of the County. He was appointed Judge in 1931 and officiated in that capacity in the County for just 10 years. The Clerk has conveyed to his family the sympathy of the Council.

Since his death the Minister of Justice for Canada has appointed Mr. James G. Harvie, Orillia, as County Judge; he declared to the eath of allegiance and of effice on Oct. 31st last.

I, with some of you, have known Judge Harvie for many years, and I am sure he will fill, with credit and distinction, the duties of his high office.

I would like to refer to the retirement of Judge Wismer who was Judge of this County for 53 years. He was held in the highest esteem by the members of the legal profession and, in fact, by all others who knew him, and it is well known that very few appeals against his judgments were successful. I am sure that you, with myself, wish him many years of good health to enjoy his well earned heliday.

You will be pleased to know of the splendid improvement in the financial position of both Midland and Collingwood, and the Department of Municipal Affairs has released them from supervision. We wish them presperity in the future.

At the June Session I referred to a timely rain that had fallen a few days previous to the Session, and expressed the wish for good crops, but owing to the extremely dry season the County, in most places, harvested the lightest crops in its history.

Owing to peer creps and low prices for farm produce, very many farms are being abandened and no tenants taking them up. In Medente Township alone there are ever 2,400 acres in abandoned farms, and now where there is a surplus of some food stuffs there may soon be a shortage, if not a famine.

The war situation is very critical and each member, as a leader and head in his own municipality, should do all in his power to promote and advance every phase of Ganada's war effort, and especially at this time through the purchase of War Saving Certificates.

The County Treasurer reports the finances of the County are in good shape. Some municipalities have taken advantage of the discount and paid their 1941 levies. It is expected the year will end with all departments keeping their expenditures within their appropriations.

I would ask you to give your prompt and careful attention to the business of the Session so that it may be completed satisfactorily and in good time.

#### SECOND DAY

Council Chamber, Barrie, Nov. 19, 1941.

The Council met pursuant to adjournment from yesterday's session. The Warden in the chair.

All the members were present.

The Minutes of the previous session were read and adopted.

The Warden presented the following communications and accounts:

G. R. Foster, Superintendent of the Children's Aid Society, re two extra social service workers.

H. G. Falkner, Publisher of the Alliston Herald, with a list of the enlisted persons from the Alliston district.

M. A. Campbell, Secretary-Treasurer of the Ontario School Trustees and Ratepayers Association.

Criminal Calendar of the County Goal showing that at the present time there are 33 prisoners confined there for various offences.

W. J. Rose, Clerk of Orillia Township, with an account for the maintenance of a post-manatorium case.

Counciller Toner, Chairman of the County Read Committee, informed the Council that County Read Engineer Jones would be in Torento Thursday and Friday, attending a Read Engineer/Convention, and he would be glad to see any of the members to-day who required information.

Councillor Luck inquired who was responsible for the care and maintenance of the grounds in front of the Goal. He noticed a heavy coat of leaves en parts of the lawn which would smether the grass.

The opinion was given that the Goal grounds, building, and staff, were under the direction of the Sheriff of the County.

Councillor Scrannage inquired if the caretaker of Mancy Island was a full-time employee and how he was paid.

He was informed that he was employed and worked under the instruction and direction of the superintendent of the Midhurst Forest Station; he worked about four months in the summer and was paid \$50.00 per month for the four months.

E. W. Jones, County Road Engineer, appeared before the Council and explained the nature and amount of work done on the County Road System during the present year. Only three small jobs of construction were undertaken this year, and consequently the County's grading machinery was rented to local municipalities.

A number of members asked questions concerning certain aspects of the road, which were answered by the engineer.

Judge Harvie, newly appointed County Judge, being in the Chamber, the Warden invited him to a seat on the dias.

He addressed the Council and stated he was a native of the County, and felt it a great responsibility to be Judge of a county the size and importance of Simcoo.

He wished to get better acquainted with the members, and invited them to make free and call on him at any time.

Moved by Councillor Drinkwater, seconded by Councillor Simpson, and ordered,

That the Committee on Agriculture consider the advisability of making the usual grant of \$100.00 each to North and South Simcoe Boys and Girls Club work.

Moved by Councillor Drinkwater, seconded by Councillor Brown, and ordered,

That the Finance Committee consider the advisability of making a grant of \$25.00 to the Trustees and Ratepayers Association of Simcoe County to earry on their work in the County.

Moved by Councillor Brack, seconded by Councillor Barker, and ordered, That the Road and Bridge Committee consider the advisability of taking over that portion of townline between Sunnidale and Nettawasaga from Burns Avenue to the Bay.

The County Clerk stated he was frequently asked by Previncial Headquarters of the Canadian War Services Fund what would be the attitude of the County in 1942 between raising by campaign or by way of levy the amount required for War Services.

The Canadian Red Cross and the Navy League of Canada would prebably be included with the other organizations for next year. It was estimated that an amount of between \$17,000,000 and \$20,000,000 would be required for all Canada.

He suggested that the matter might be considered by the Finance Committee of by a committee of the whole Council.

It was decided to take the question up in Committee of the whole Council at the morning session on Thursday.

Councillor Carlton stated that before adjournment Ex-Wardens Coombs and Dutton had a ceremony to perform.

Councillor Goombs addressed the Council and referred to the services of Warden Barr. In his experience, no former Warden had given better attention to his duties. He had presided with directness and impartiality. In years to come George Barr would be remembered by the fine forests in the County which are a result of his work for reforestation.

Mr. M. Morrison, President of the Children's Aid Society of the County, and Mr. G. H. The society is frequently asked to assist mothers with small families whose husbands are on Active Service, and probably overseas, and who probably were not the best managers in the first place. When their children became sick they asked the society to assist and it is their duty to do so.

They were endeavouring to give service in each case but were handicapped by lack of sufficient social workers, and would like to have the approval of the Council to secure at least two more workers.

Mr. Morrison addressed the Council and spoke of the serious problems imposed on the society as the result of the war, which was aggravated on account of the proximity of Camp Borden. He referred to the increased number of cases that came under their care.

The Society was a corporate body and at a recent meeting a resolution was passed authorizing the employment of two more social workers.

He asked for the full co-operation of the members of the Council.

The Warden assured the deputation that their request would have the sympathetic consideration of the Council.

### AFTERNOON SESSION

The Council met pursuant to adjournment from the morning session.

The Warden announced that there was a deputation present to address the Council with reference to recruiting.

The deputation was composed of Mayor Pack, Orillia, Mr. Harold Hale, Orillia, Mr. W. J. Cranston, Midland, Mr. W. H. Hamilton, Barrie, and Mr. W. J. Smith, Collingwood.

Reeve Oliver of Orillia introduced Mr. Harold Hale.

Mr. Hale said the Department of Defence for Canada had put on a demonstration in Toronto on Friday and Saturday of last week showing what had been done in Canada by way of furnishing men and equipment for the army.

He stated it was the intention of the Department to recruit up to six complete divisions, but that at the present time recruiting was rather slow.

He suggested that recruiting committees be established in various centres with a local central committee, which committees would work in connection with recruiting officers.

He also suggested that the County establish a credit of about \$25.00 for recruiting, to be administered by the Central Committee appointed by the County Council.

Mr. Hale stated the needs of the army ares great, if not desperate, at the present time, and our very existence as a nation is at stake in the struggle now going on;

Mr. W. J. Cranston addressed the Council and stated that in Torente all in attendance were impressed with the desperate needs of the army. Perhaps civilians had not done all they could with regard to helping in these matters, and it was required to shake the people out of their complacency and thereby assist the Department in its recruiting efforts. If all worked together it might be possible to get more men.

Mr. J. W. Smith stated it was a pleasure to renew acquaintances with his old associates. One difficulty in securing recruits to-day was that for the past twenty years we all had been preaching "peace", but a certain person had interfered and said there would not be peace.

There were not more than 50,000 men recruited up to the present -- not half of the number that recruited in the last war.

Perhaps he was not altogether in favour of voluntary enlistment, but that was the Government(s policy, and we all should be patriotic in assisting in every way possible.

Mr. Hale in reply to a question stated that there should be a small central committee with other committees named at strategic points.

After some discussion the Warden assured the deputation that their request would be considered by the Council at a session of Friday morning, and declared the Council adjourned until Friday at 10 A.M. Standard Time.

Mr. F. A. Lashley and his Boys Potato Team were invited to the front of the Council Chamber. Mr. Lashley addressed the Council, outlining the boy's work and the steps leading up to their winning the Mational Club Contest in potatoes.

Councillors Barker and Simpson presented each of the boys with an alarm cleck.

Edwin Pearson thanked the Council and gave the credit to their coach, Mr. Lashley, and those who directed them in the work, for their achievement.

Arthur Nicol also thanked the Council, and outlined the trips and entertainments given the boys and girls taking part in the National Contests.

Mr. Lashley thanked the Council on behalf of the beys.

Councillor Brown said this achievement was a direct result of the work of the School Fairs, and he urged that this work be continued.

Much credit is due Mr. N. Boadway, Manager of the Elevator, for his efforts and influence with the grain companies.
