Hellock shall enter into a bond with this Corporation and the  
Corporations of the Townships of Enna and Leumeth to  
be approved of and prepared by the County Solicitors  
indemnifying this Corporation and said Townships against  
any claim for damages or otherwise that may arise out of or  
be occasioned by the erection of said poles or the stringing  
of Electric wires thereon, said poles to be allowed to remain  
or be continued in such positions for the period of twenty  
years from the 1<sup>st</sup> day of January 1905 and thereafter during  
the pleasure of this Council
