All the nominees, with the consent of their movers and seconders, having withdrawn, with the exception of Edward Dutton, Reeve of Victoria Harbour and Denis Nolan, Reeve of Bradford, the Clerk proceeded to take the vote, and Councillor Dutton, receiving the votes of the majority of members present, the Clerk declared him duly elected Warden for the year 1934.

At the request of the Clerk, Mr. E.B. Brown, Police Magistrate, Victoria Harbour, administered the declaration of office to the Warden elect.

The Warden then took the chair.

Mr. E.B. Brown addressed the Council and congratulated the Warden. He said that he considered it an honour to administer the oath of office to him as he was Clerk and Treasurer of the Municipality of which Mr. Dutton was Reeve, and he found him a capable Municipal man and a warm friend. He was sure the Council had made a good choice, and would be well satisfied with his service at the end of the year.

The Warden requested the representatives of the Ministerial Association of the Town of Barrie to open the proceedings of the Council.

Dr. Shortt, M.A., D.D., addressed the Council and referred to the relations of the church and state, stating that the civil powers held their authority from the same power as the church. History records conflicts between church and state, but he hoped this would not occur again, and that the harmonious relations at present existing, would continue, and that by working together the church and state would make the world a better place to live in and bring about better conditions and restore the world to normal conditions.

Rev. E.E. Long, B.A., B.D., then offered prayer.

That a vote of thanks be tendered to Mr. E. B. Brown for his services in administering the oath of office to the Warden elect, and for his interesting and beneficial remarks. Mr. Long, in connection with the opening of Simcoe County Council for the year 1934.

The Warden then addressed the Council and stated he was pleased that the Clerk and Treasurer of Victoria Harbour, the Municipality he had the honour to represent, and Police Magistrate of that part of the County of Simcoe, had been called on to administer the oath of office. The contest between himself and his opponent had been that of the most

most friendly kind, and he was sure that he would have his assistance and support in all things pertaining to the welfare of the County. He would give his best efforts in the interests of the County and asked the co-operation of all the Members.

He thanked the representatives of the Ministerial Association of Barrie for giving their time to attend and officiate at the opening.

The Warden invited Mayor Craig of Barrie, Dr. L.J. Simpson, M.P.P., and Ex-Wardens Scanlon, Coombs, Eplett, Carlton, and Cunningham, to seats on the dias.

Each of the above addressed the Council and congratulated the Warden on his election, and referred to the improvement in world conditions. The hope was expressed that business would continue to improve and that the Council and County of Simcoe would have a prosperous year.

Council chamber, Barrie,
June 11th, 1934.

The Council met pursuant to the adjournment at the January Session.

The Warden in the chair

The Warden addressed the Council and welcomed the members and was pleased all were able to attend the Session.

He reported that the County Road Committee had visited Mr. Isaac Scott, last year's Warden, and he expressed the hope that he would again be able to visit the Council.

He referred to the death of Mr. F.W. Fenton, Port McNicoll, and Mr. Geo. Sinclair, Orillia, former members of the Council, stating that their passing was a loss to the County and particularly to their own municipalities.

The severe winter had caused great loss to the farmers in the County, practically all the fall wheat and clover had been winterkilled and pastures had been very short. The recent rain was very welcome and would make rapid growth, and he trusted a satisfactory harvest would be reached.

The financial position of many of the municipalities had been greatly improved. they had been able to collect arrears of taxes and considerable amounts of arrears of County levies had been paid.

He requested the members who had resolutions or business to bring before the Council to do so early in the Session in order to give sufficient time for consideration and at the same time facilitate the work of the Session.
