Rev. Ingram stated he was asking the County Council to sponsor a County Library Board. He was not asking for money at the present time but to ratify the constitution for appointing a County Liabrary Board. Such an Association would assist the smaller communities to have the advantage of public libraries and to teach the young people to read good literature.

Mrs. Montague Leeds stated that she was interested in the matter of a County Library Association and contrasted the advantages and possibilities of the people in the town and city as compared with those in the country. He stated that this Conference was of more importance and far reaching than anything that had been undertaken in the interests of farmers for some time. The meeting

would be held in the Odd Fellows' Temple, Barrie, and arrangements were being made for a large attendance. Farmers should be more active in the selling and marketing of their products and he hoped this Conference would have the necessary effect.

During the past year, crops were mainly satisfactory as were most farm prices.

The war was causing special attention to increasing farm products and Simcoe County was in a position, on account of the work already done, to undertake the raising of more grain crops and increased production of hogs and bacon.

He referred to the splendid work that has been done in the County by Reforestation and the report of the Department gave special notice of the work in Simcoe County.

Numerous agricultural short courses were being conducted in the County at the present time with satisfactory attendance. He thanked the Reeves and Deputy-Reeves for their assistance and co-operation in this work.

The T. B. testing in the County was progressing as favourably as could be expected with the number of veteranaries available as there were tests being conducted in seventeen other Counties in the Province at the present time.

He stressed the importance of Junior Farmer work and suggested they co-operate with the agricultural societies.

He also referred to the importance of the crop improvement associations which are doing spendid work in the County.

Mr. Gordon Foster appeared before the Council to explain the connection between Mrs. Cora Godfrey and the Children's Aid Society. He stated Mrs. Godfrey had received assistance from the County from 1925 up to Dec. 1st, 1937, being paid during this time an amount nearly \$4500.00, and as she had only one child under 16 years of age Magistrate Bick gave an order terminating the order for assistance. In his opinion, here was a case in which relief might be given.

SPECIAL MEETING

Council Chamber, Barrie, February 20th, 1940.

At the call of the warden, the Council met in Special Session upon the request of the Department of Municipal Affairs to pass a By-Law guaranteeing the refunded debentures of the Corporation of the Town of Collingwood.

The Warden in the Chair.

All the Members were present.

The Clerk read a letter from Mr. J. H. Fawcett, Clerk of the Town of Collingwood, advising that it would be necessary to call a Special meeting of the Council and also the instructions from the Warden to notify the Members to attend at a Special meeting to guarantee the refunded debentures of the Town of Collingwood.

The Warden feelingly referred to the death of Lord Tweedsmuir, Governor-General of Canada. He had special qualifications as the King's representative in these particularly trying times and satisfactorily performed his duties and was beloved by all classes of Canadians.

He referred to the death of the wife of Harry Wright, Deputy-Reeve of Midland, who had passed away suddenly since the January Session. He extended to Councillor Wright his own and the sympathy of all the Members of the Council.

He welcomed Councillors Dutton and Coombs, who were not able to be present at the January Session and was glad to see them improved in health.

Councillor Dutton thanked the members of the Council for their kind-ness to him throughout his illness.

Councillor Coombs also thanked the members for their expressions of sympathy and kindness during his illness.

Councillor Wright expressed his appreciation of the sympathy shown him by the members of the Council.
