OF THE SPECIAL SESSION, HELD FEBRUARY 20th, 1940, OF THE MUNICIPAL COUNCIL OF THE COUNTY OF SIMCOR

#### SPECIAL MEETING

Council Chamber, Barrie, February 20th, 1940.

At the call of the warden, the Council met in Special Session upon the request of the Department of Municipal Affairs to pass a By-Law guaranteeing the refunded debentures of the Corporation of the Town of Collingwood.

The Warden in the Chair.

All the Members were present.

The Clerk read a letter from Mr. J. H. Fawcett, Clerk of the Town of Collingwood, advising that it would be necessary to call a Special meeting of the Council and also the instructions from the warden to notify the Members to attend at a Special meeting to guarantee the refunded debentures of the Town of Collingwood.

The Warden feelingly referred to the death of Lord Tweedsmuir, Governor-General of Canada. He had special qualifications as the King's representative in these particularly trying times and satisfactorily performed his duties and was beloved by all classes of Canadians.

He referred to the death of the wife of Harry Wright, Deputy-Reeve of Midland, who had passed away suddenly since the January Session. He extended to Councillor Wright his own and the sympathy of all the Members of the Council.

He welcomed Councillors Dutton and Coombs, who were not able to be present at the January Session and was glad to see them improved in health.

Councillor Dutton thanked the members of the Council for their kindness to him throughout his illness.

Councillor Coombs also thanked the members for their expressions of sympathy and kindness during his illness.

Councillor Wright expressed his appreciation of the sympathy shown him by the members of the Council.

On the arrival of Messrs. Gray and Carter the Council resumed.

Mr. Gray addressed the Council on the question of the County borrowing on debentures, money to provide for the arrears of levies of the Local Municipalities at an interest rate lower than 4%. He also stated the Ontario Municipal Board had approved of the Plan prepared by the Department of Municipal Affairs for the refunding of Collingwood debentures and he felt the annual payments were such that both the Town of Collingwood and the Collingwood Terminals Limited could meet them without any further default.

The Clerk had first wired the Ontario Municipal Board for authority
for the County to guarantee these debentures and had received a reply granting the authority.

# OF THE JUNE SESSION, 1940, OF THE MUNICIPAL COUNCIL OF THE COUNTY OF SINCOR

### FIRST DAY

Council Chamber, Berrie, June 10th, 1940.

The Council met pursuant to adjournment at the January Session.

The Warden in the Chair.

All the members were present.

The minutes of the January Session of the Council and the Special Session in February having been printed and distributed were taken as read.

The Warden addressed the Council and referred to the death of the father of Councillor Apperley, Deputy-Reeve of Tecumseth township. On behalf of the Council he extended to him their sincere sympathy.

He stated that in most sections in the County the crops had a splendid appearance, although in the low lying sections the excessive rainfall during the spring had retarded seeding operations.

The By-law passed at the Special Session of the Council in February, authorizing the issue of debentures for \$90,000.00 to take care of the loan from the Bank, had not been acted on.

He, with Councillor Lawrence, Chairman of the Finance Committee, had decided to not act on the By-law without further consideration by the Council and it was for the Council at this session to give instructions regarding putting the provisions of the By-law into effect.

He congratulated the County Property Committee on the improvement in the appearance of the grounds in front of the Court House and also the County Road Committee and the County Road Superintendent in commencing to put down a hard surface on some of the County Roads.

The Warden presented the following communications and accounts and they were referred to their respective committees.
