The Clerk Called the Council to order and requested them to elect one from among their number to be Warden of the County for the year 1941.

He had received notice that Councillor Gratfix was confined to his home through illness and would not be present at today's session, of which he was sure all the members regretted.

On account of the number of voters on the voters' list, the Reeves and Deputy-Reeves of Barrie, Orillia and Innisfil Township had two votes each in the Council and the Reeves of Collingwood and Midland had two votes each.

The Clerk appointed Councillors Coombs and Dutton to act as scrutineers and declared the nominations open for the position of Warden for 1941. The rules and regulations of the Council provided fifteen minutes for nominations.

All the nominees, with the consent of their movers and seconders, having withdrawn, with the exception of Councillor Barr, Reeve of Medonte Township, the Clerk declared him duly elected Warden of the County of Simcoe for the year 1941.

Police Magistrate Compton Jeffs held special Court and administered the declaration of office to the Warden elect.

He congratulated the Warden on his election and especially in receiving an acclamation. He referred to the particularly trying times prevailing at the present time. This was a time when administrative bodies should be diligent in the discharge of their duties.

He wished the Warden and the Council a successful year.

The Warden then retired to assume his robes of office.

The Warden then took the Chair.

The Barrie Ministerial Association, represented by Rev. N.R.D. Sinclair and the Rev. H. A. Jamieson, were present and the Warden requested them to open the proceedings of the Council with devotional exercises./ Mr. Jamieson read a portion of scripture and Rev. Mr. Sinclair addressed the Council and offered prayer.

The Warden addressed the Council and thanked the Members for the honour done him by electing him Warden by acclamation.

He would do his best in fulfilling his duties and asked for their full co-operation and support.

The Warden appointed Councillor Toner, Reeve of Flos Township, as Chairman and the Reeves of all the Municipalities as a Striking Committee to name the Standing Committees for the year.

The Council adjourned for three minutes to enable the Striking Committee to bring in the report.

The Council resumed as per adjournment.

He referred to the reduction in the arrears of County levies which was reflected in the reduction in the amount owing the banks.

With a levy mf 1941 the same as 1940 and expenditures similar to 1940 and with all arrears of levies paid, the County would be in the position of not owing anything to the Bank.

At the present time there are no debentures which are guaranteed by the County in default of payment.
