First Day

Council Chamber, Barrie, June 15th, 1942.

The Council met pursuant to adjournment from the January Session.

The Warden in the chair.

All the members were present except Councillors Gropp, Ferguson and

Bingham.

The Clerk presented Certificates of Election and Declaration of Office for Bruce Eplett, Reeve of Victoria Harbour, and C. T. S. Evans, Reeve of Bradford.

The Minutes of the January Session and the Special Session of March 11th of the Council, having been printed and distributed, were taken as read.

The Warden welcomed the members to the June Session, particularly Bruce Eplett as Reeve of Victoria Harbour and C. T. S. Evans as Reeve of Bradford. They succeed two former members who were in attendance at the January Session of the Council but who have since passed on. These were Ex-Warden Edward Dutton, Reeve of Victoria Harbour, and Ex-Warden J. E. Coombs, Reeve of Bradford.

Councillor Dutton died on March 1st, having been a member of the County Council for many years. He first became a member in 1915 as Deputy-Reeve of Tay Twp. He was Deputy-Reeve in 1916 and 1918 and Reeve in 1917 and 1920. He was out of municipal politics for a few years but has been Reeve of Victoria Harbour continuously since and including 1925. He was Warden of the County in 1934.

Mr. Dutton took an active part in all municipal affairs, being a member of the County Road Committee for a number of years and Chairman of the County Reforestation Committee when the first County Forest was started in 1922.

councillor Coombs, an experienced and valuable member of the Council, was first elected Reeve of Bradford in 1918, and was Reeve continuously from that year until 1927. He was Warden of the County in 1924. He was out of the Council from 1927 to 1935 but was again elected Reeve in that year and continued in that position until his death on May 17th.

For many years he was Chairman of the Standing Committee on Education and always took an active and intelligent interest in municipal affairs.

Ex-Warden McKinlay, for many years Reeve of Oro, was called by Death on May 10th, 1942. He was Warden of the County in 1925 and was first elected to the County Council in 1916. He was a member continuously, until his Wardenship, with the exception of the years 1920 and 1923.

He was one of the pioneers of Oro Township and witnessed many improvements and developments during his life.

Since June, 1941, three other Ex-Wardens of the County have died, making six deaths in that body within a year. They are A. P. Potter, Warden in 1915, died in June, 1941; Chas. J. Gratrix, Warden in 1929, died in November, 1941; and Digby Horrell, Warden in 1917, died in January, 1942.

The Warden said he regretted to have to report that on account of the excessive rainfall since the first of May many farmers on the low clay land were unable to sow a bushel of grain, and owing to the lateness of the season it appeared that there would be real hardship for some farmers this coming year. This is the more to be regretted as the country, on account of the war, requires all the food stuffs it can produce.

At the January Session the County passed a By-Law providing for a total expenditure of \$125,000.00 on the County Road System for maintenance work. It was returned from the Provincial Highways Department with a total expenditure of only \$86,000.00 approved.

The Warden stated that it cost a donsiderable amount to put the roads in good condition after the frost went out in the spring and accordingly there will not be more than enough funds left to barely maintain the roads, and not enough to maintain them as they should be.

He was sorry he couldn't speak optimistically of the war situation at the present time, but as the United Nations' output of war equipment has vastly increased the Allies will soon have more planes and tanks than the Axis Nations and there will be a turning in our favour soon.

The Warden requested each committee to carefully scrutinize all expenditure in order to keep the tax rate as low as possible. He also asked the members to be punctual at the sessions of the Council and the various Committee meetings so that the business of the session might be concluded as expediously as possible.

Councillor George Patterson said he had a matter he wished to bring before the Council. He spoke as follows:

MAT this time and before the proceedings of this assembly are taken up I should like to say a word or two in respect to the loss sustained by the County, since and shortly before the January Session, in the death of the following County representatives and Ex-Wardens.

I should like also to suggest that the Clerk, Mr. Simpson, record in the minutes of this session a reference of the municipal and county services of these now deceased members in order that a record of their services be preserved in the history of this County which they served so well.

I refer to Ex-Wardens Chas. J. Gratrix, Edward Dutton and J. Ed. Coombs, Donald McKinlay, A. P. Potter and Digby Horrell. All will miss these men who have been, for so many years, generous friends and public servants and devoted much of their lives to their municipalities, their County, their province and their Country. No eulogy need be spoken for their works stand as a monument to their memory.

It seems fitting that the following verses be applied to them and their works;

"Let us now praise famous men and our Fathers that begat us,
Such as did bear rule in their Kingdoms,
Men renowned for their power, giving counsel by their understanding,
Leaders of people by their counsels, and by their knowledge
of learning, meet for the people, wise and eloquent in their instruction,
Men furnished with ability, living peaceably in their habitation,
These were honoured in their generation and were the glory of their times,
There be of them that left a name behind them, that their praises
might be reported,
Their bodies are buried in peace but their name liveth for evermore."

The Warden thanked Mr. Scott for the information given the Council in this matter.

A deputation from the Council of Mulmur Township, composed of Messrs George Dodsworth and Clifford Duffin, appeared before the Council and asked that the County of Simcoe add one mile of road, in the County, to the County Road System to make a connecting link in the two County Road Systems of Dufferin and Simcoe. The addition asked for is the line between Lots 25 and 26 Concession 1, Tossorontio Township, which connects with County Road No. 5.

The Warden assured the deputation that their request would be carefully considered by the Road & Bridge Committee.

Two deputations from the Town of Midland, one representing the Midland Red Cross Branch and the other the Midland Chapter of the Imperial Order of the Daughters of the Empire, waited on the Council and requested assistance for these two organizations. Mr. Ralph Wilson addressed the Council in connection with assistance for the Red Cross. He outlined the work accomplished by the local branch and assured the Council that any grant the County might see fit to make would be greatly appreciated and used to the very best advantage.

Miss Mary Benson and Mayor Oliver Smith addressed the Council in the interest of the Midland Chapter of the Imperial Order of the Daughters of the Empire. Mayor Smith congratulated the Warden on being elected to the high office he holds.

The Midland Chapter was formed in 1914 and has carried on continuously since. He outlined the many services performed by this organization and stated it was giving valuable assistance to those in need in Poland. He urged that assistance be given to both the Red Cross Branch and the Chapter of the Daughters of the Empire.

He introduced Miss Benson, Regent of the Midland Chapter, who presented a Financial Statement of their Chapter for the past year. Both stressed the important work being done by that organization.

Messrs S. L. Page, F. A. Lashley and J. McLeod appeared before the Council in connection with the annual meeting of Weed Inspectors in the County.

Mr. Page referred to the shortage of gas and car tires, and it was accordingly thought advisable to hold this annual Weed Meeting at the time of the June Session as many of the County Council members attended these meetings. He referred to the unusually wet season which resulted in from 30% to 40% of the spring grain in the County being left out of the ground. He said that steps were being taken to give all possible assistance in harvesting the crops this year.

Mr. Lashley referred to a programme of sheep production in the County. The Departments of Agriculture, both Dominion and Provincial, have requested an increase in sheep production which would automatically increase the production of wool. It is asked that the sheep production be increased by at least 25%. Mr. Lashley outlined a policy that has been prepared by the Simcoe County Agricultural War Production Committee and urged the members to take this matter up with their ratepayers. He introduced Mr. J. McLeod of the Department who was to address the Council and Weed Inspectors on the question of weed eradication.

Mr. McLeod urged that every effort be made to destroy all noxious weeds as they greatly depreciated the value of farm crops, and total crop production is very necessary at this time. He said that everything was being done by his Department to give instructions to municipal Weed Inspectors and County Road Superintendents to keep the weeds destroyed.

The Warden thanked Messrs Page, Lashley and McLeod for the useful information given to the Council.
